Extended opening hours - 0800 - 2000

Since opening and operating until 1800 we've noticed, especially on sunny days, lots of people still relaxing and enjoying the Killacourt. It seems a shame to close so early when the evenings are light and there is an atmosphere in the area.

Permission to install pergola

To provide year round shelter from rain and sun

Make the most of the bi-folding doors and offer an all year round al fresco experience

The pergola will have two stages both being 3m x 4m. The outline will be 3x4 they will fix to the ground not to fly away in the wind.

From the doors out 3m and along 4m from the wall, just in the front courtyard. The height is 2.10m

Change outline of premises

To include the outside terraced area, where the only footfall leads to the cafe and there is no thoroughfare.

At present the outline is of the unit only, we'd like to define the actual working space to include the outside terrace area that belongs to the unit. With outside seating, this change is necessary in relation to licensing - public liability, media and cooking demonstrations and charity events.

At Mothersurf we want to work with you to create a green surf tourism future for

Newquay.
